

**RESOLUTION OF THE  
BOARD OF DIRECTORS OF THE  
FALCON HIGHLANDS METROPOLITAN DISTRICT**

**WATER CONSERVATION POLICY**

WHEREAS, the Falcon Highlands Metropolitan District (the “**District**”) is a special district in El Paso County, Colorado, organized pursuant to Article 1 of Title 32, Colorado Revised Statutes, known as the Special District Act; and

WHEREAS, pursuant to the Special District Act and its Service Plan, the District provides water service to its customers and is empowered to adopt, amend and enforce regulations related to this service; and

WHEREAS, the water the District provides to its customers is obtained from Denver Basin groundwater; and

WHEREAS, the District has adequate water to serve its current customers for the foreseeable future; and

WHEREAS, the District, in an effort to further extend the lifecycle of its water supply for its customers, wants to encourage water conservation by its customers; and

WHEREAS, the water conservation efforts will also provide the District additional time to secure additional water rights to ensure adequate water will be available for its current and future customers; and

WHEREAS, to conserve its water resources and to ensure continued water availability to its customers, the District has determined that it is necessary to enact a water conservation policy applicable to all of its customers; and

NOW THEREFORE, the Board of Directors of Falcon Highlands Metropolitan District resolves as follows:

1. Beginning April 15, 2014, the following water conservation policy will be in effect until otherwise modified or repealed by the District:

a. **OUTDOOR IRRIGATION**

i. **Spray Irrigation**

1) **Limit on Size of Irrigable Area**

a) No single residential lot shall have more than 2,500 square feet of area irrigated by spray irrigation.

2) **Irrigation Days**

Resolution re Water Conservation Policy

a) Spray irrigation is limited to three days per week in accordance with the following schedule:

|   |                                |
|---|--------------------------------|
| All customer addresses ending in an even number | Tuesday, Thursday and Sunday   |
| All customer addresses ending in an odd number  | Monday, Wednesday and Saturday |

No spray irrigation is permitted on Friday.

3) All Outdoor spray irrigation must occur between 6:00 p.m. and 10:00 a.m.

ii. Drip Irrigation

1) No limit on days, irrigable area, or frequency of use of drip irrigation.

iii. Hand Watering of Annual and Edible Plantings

1) No limit on days, irrigable area, or frequency of use of hand watering of annual and edible plantings.

b. ADDITIONAL RESTRICTIONS

| Washing of impermeable surfaces including driveways and sidewalks | Not permitted at any time  |

i. All watering must be done in a manner to prevent water waste and overwatering.

ii. Do not waste water by letting it pool in gutters, streets or alleys.


iii. Do not waste water by letting it spray on concrete or asphalt.

iv. Do not water while it is raining or during high winds.

2. Special Allowances – Special allowances are available for establishing new landscaping in the months of April, May, September, and October. A \$100 permit fee will allow watering 4 days a week for 4 weeks only, and will be limited to 1 inch of water per zone.
